Probable Cause

At 1042 Hours on 7/23/25, Kristi Goncalves received a threatening text message from the following phone number: [REDACTED] The text message, sent by an unknown suspect, suggested that the sender was sitting near Kristi in court during the Brian Kohberger sentencing. The suspect's text asserted that Bryan [Kohberger] was innocent and further indicated that the sender provided Kristi's home address to a wannabe serial killer in Moscow, Idaho. Kristi understood this message to be a threat against her life and feared for her safety as a result.

A carrierlookup.com search showed the sender's phone number was a Voice Over IP (voIP) phone number, provided by the SINCH telecommunications group. Further investigation showed the phone number was related to TextMe, Inc. An [REDACTED] search of the same phone number returned no results. A preservation request was submitted requesting TextMe, Inc retain records related to the phone number pending service of a search warrant.

Narrative:

At 1042 Hours on 7/23/25, I was assigned to the Ada County Courthouse located at 200 W Front St, Boise, ID. While I provided security for the Brian Kohberger sentencing, a victim family member, Kristi Goncalves, told me she received threatening text messages from an unknown sender. I briefly read the text messages, which indicated the sender had conspired with serial killers to harm Kristi. Kristi understood this message to be a threat against her life and feared for her safety. While the text suggested the sender was sitting in the courtroom near Kristi, the public and victim families were seated separately for the hearing and imminent danger was not likely. Nevertheless, I advised the trial security team of the message and requested security control scan for threats via in-court CCTV cameras. I provided Kristi with my contact information and advised her to contact me at the conclusion of sentencing if she wished to report the crime.

At 1250 Hours on 7/24/25, I received a telephone call from Kristi's attorney, [REDACTED] [REDACTED] indicated Kristi wanted charges to be brought against the sender of the threatening text messages. [REDACTED] sent me an email with screen captures of the text messages. What follows is a verbatim transcription of the messages, as depicted in the screen captures provided. (See Attached)

*Sitting near you in court and watching you is a joke
You know that Bryan is innocent
Making threats to Bryan about getting r4ped in prison was very
silly,I am in contact with a lot of serial killers including BTK and
I've been put in contact with a wannabe serial killer who is in
Moscow idaho and I have given him your address the same
with [REDACTED]
[REDACTED] and some others
I have now contacted the FBI and given them everything this
includes,Hanks Escorting,MO TEL and TRAVELLERS MOTELS
the invoices on the fraud from [REDACTED] GOFUNDME
account,the link to the twitch live stream,you have messed with*

I submitted a CARRIERLOOKUP search for the phone number [REDACTED] which returned the following:

The number [REDACTED] is a voip by SINCH (FKA INTELIGUENT/NEURTRAL TANDEM)

In my training and experience, Voice Over IP (voip) services are commonly used by bad actors to harass or scam victims, as these numbers can difficult to connect to their owners.

I conducted an [REDACTED] search of the [REDACTED] phone number. There were no return results, which indicated the phone number was not associated with a particular individual.

I received communication from Detective Matt Buie via email. Detective Buie indicated he performed a search via the Inteliquent Portal to find a more specific carrier for VoIP phone numbers. In this case, he searched the phone number: [REDACTED], which returned a "TextMe, Inc." carrier. He provided me a screen shot of the return in the same email. (See Attached)

I emailed a preservation letter to TextMe, Inc which advised them of the criminal investigation and requested they preserve all records related to the [REDACTED] phone number from July 21, 2025 through July 29, 2025.

On 8/5/25 I drafted, submitted, and was approved for a search warrant for the aforementioned records. I served the warrant on TextMe Inc via email.

Narrative:

On 8/12/25 I received correspondence from TextMe, Inc. in response to my search warrant service. TextMe representative [REDACTED] provided a business records affidavit intimating that she was an agent of TextMe, Inc, that she was familiar with the manner in which its records were created and maintained, and that she retrieved true and correct copies of basic subscriber information and transactional records related to the phone number "[REDACTED]" from 00:00 July 21, 2025 to 23:59 July 29, 2025.

The first subscriber information report for [REDACTED] identified User ID [REDACTED] [REDACTED] with a verified email [REDACTED] and Google ID [REDACTED]. The account was created Jan 2, 2025 and was last logged in on July 26, 2025 from IP [REDACTED] (signup IP [REDACTED]). One device was linked (model NDL-W09, device ID [REDACTED]). The number + [REDACTED] was allocated July 23, 2025 and was withdrawn July 24, 2025. Records showed extensive two-way texting on July 23, 2025 with +1 [REDACTED] brief inbound calls from # [REDACTED] on July 24, and zero-duration outbound call attempts that were placed to + [REDACTED] on July 23. An in-app "Premium" purchase (\$9.99) was applied July 23, 2025.

The second subscriber report for phone number [REDACTED] identified user ID [REDACTED] [REDACTED] with verified email [REDACTED]. The account was created and last accessed on July 26, 2025 from IP [REDACTED]. Two Android devices were linked, with device ID [REDACTED] active during messaging. The number was assigned July 26–Aug 2, 2025, with records showing multiple incoming texts from [REDACTED] and outgoing texts to several U.S. numbers on July 27, 2025.

Based on the timing of the threatening text, and the opening/closing of the [REDACTED] account on the 23rd/24th, I narrowed my investigation into that specific account. A reverse IP Lookup of the associated addresses returned a GPS location of Canterbury England (United Kingdom).

Google Search Warrant Observations

On September 30, 2025: I received a search warrant response from Google, a subsidiary of Alphabet Inc. The following are observations made based on the provided Google account records, billing summaries, device configuration files, and captured screenshots. (See Attachments)

The Google account tied to [REDACTED] resolved to Google Account ID [REDACTED] and Billing Customer [REDACTED] via Google Pay Records. The account appeared on three HONOR Android devices (a tablet and two handsets), all configured to **Locale = en-GB** and **Timezone = Europe/London** with overlapping emails of [REDACTED]. These emails were linked to the Android profile and were corroborated by cookies stored on Google servers.

Suspect Social Media

The Gmail account [REDACTED] confirmed active through multiple platform notifications, including YouTube comment activity and Google subscription correspondence. Screenshots demonstrate direct ties to the YouTube username [REDACTED].

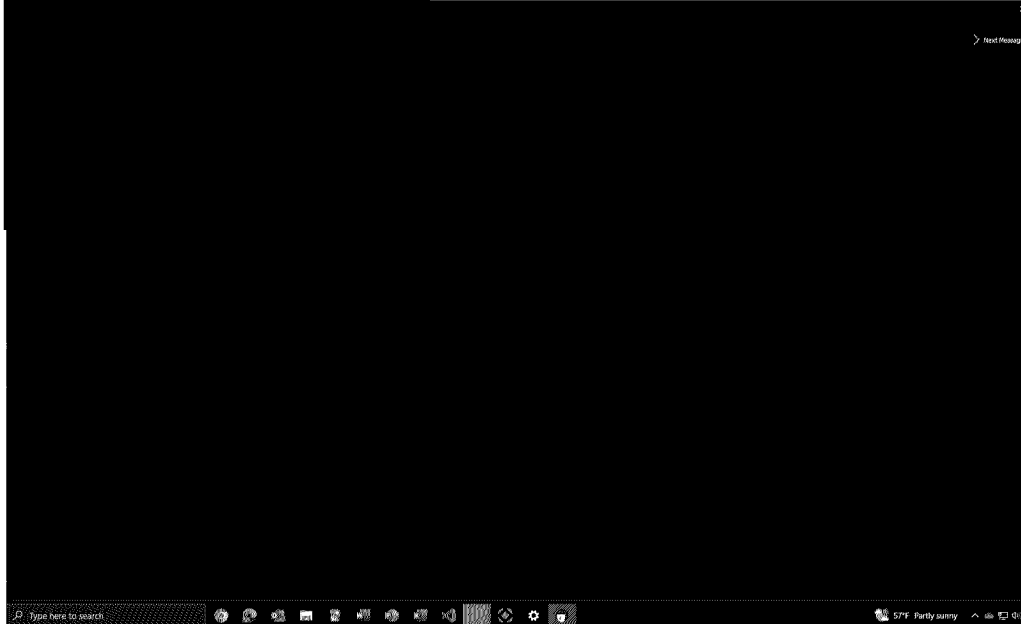

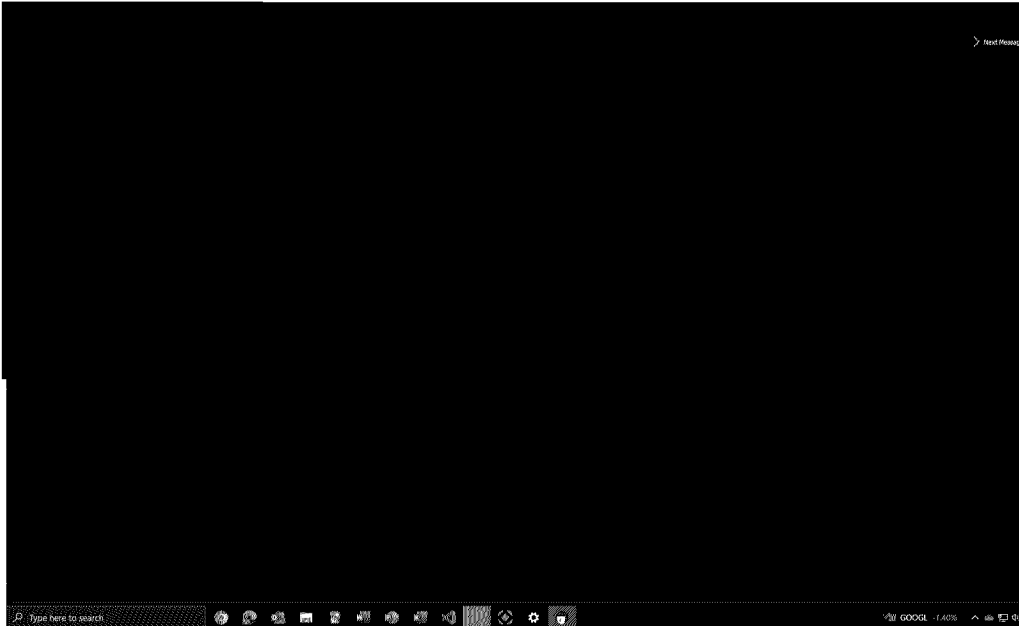

The YouTube channel associated with the [REDACTED] username releases videos and shorts covering serial killers and crime conspiracies. In one such video at url: [REDACTED] I could hear a male voice with an English accent describing a planned visit with an incarcerated serial killer with whom he had been long-time pen pals. In another video [REDACTED] made a guest appearance in the video located at url: [REDACTED], where he was interviewed on his opinions of the Kohberger case. The [REDACTED] account was made popular for its conjecture on the Brian Kohberger case and maintains the opinion that Kohberger was innocent and framed. The reference to intimate knowledge of other serial killers, as well as sympathy toward Brian Kohberger, was consistent with the sentiments in the threatening text message received by Kristi Goncalves.

Google billing records tied to payments profile ID [REDACTED] revealed a customer display name [REDACTED] and confirmed that the billing instrument was registered to [REDACTED] with a UK-issued MasterCard debit card (expiring [REDACTED]). This links the [REDACTED] account to a probable real identity of [REDACTED] located within the United Kingdom.

An additional screenshot of a Vinted transaction shows a sale associated with the same account, tied to a delivery address in Whitstable, United Kingdom. Vinted is an online peer-to-peer marketplace app where users can buy, sell, and swap secondhand clothing, accessories, and other personal items.

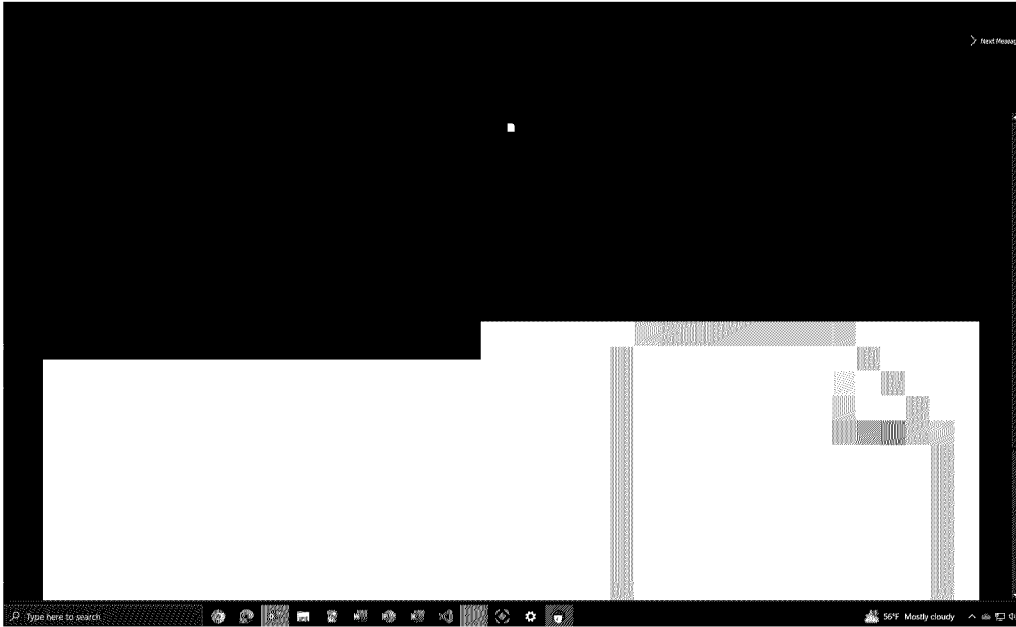

Screenshots also confirm repeated Google Play subscription correspondence for YouTube Premium. These emails further substantiate the account's ownership and continuity of use, tying the suspect to ongoing financial activity.

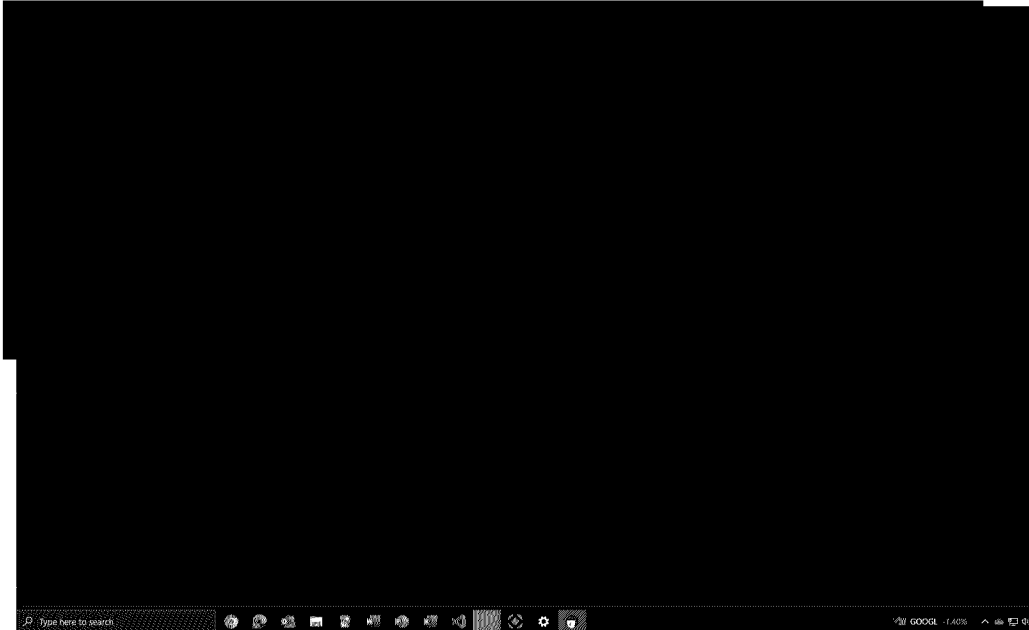

In conclusion, google evidence suggested the [REDACTED] identity was tied to multiple online platforms including YouTube, Google Play, and device registrations. Billing records identify the account holder as [REDACTED] UK-based.

Based on the aggregated Google activity records, the account [REDACTED] (linked to [REDACTED]) demonstrated repeated logins and service usage across a consistent cluster of IP addresses. Most of these addresses fell within the [REDACTED] range, with additional connections from [REDACTED] blocks. These ranges were strongly indicative of UK-based broadband/mobile providers.

Specifically, the IP [REDACTED] showed long-term continuity of use from **May 2024 through late September 2025**, suggesting a primary residential or mobile connection. Supporting this, IPs [REDACTED] were also active across the same period, suggesting the subject either maintained multiple devices on the same ISP or cycled through dynamic addresses assigned within the same provider pool.

The IPs [REDACTED] appeared as secondary connections, active between November 2024 and February 2025. These may represent an alternative residence, mobile carrier fallback, or travel-related connectivity. Meanwhile, [REDACTED] show shorter but repeated use in early 2025, further reinforcing that the subject accessed Google services consistently within the United Kingdom, possibly moving between Kent and surrounding Southeast England service areas (given corroboration with the Whitstable Vinted

Taking the long-term, repeated activity across the [REDACTED] block into account, the most likely persistent service location for the suspect was **Southeast England, United Kingdom**, with particular confidence in the **Kent region**. This aligns with the Whitstable address already documented in Vinted transaction records.
