NARRATIVE:

On 06/19/2024 at approximately 2207 hours, Deputies Flory, Davison and I (DH. Smith) responded to a call of a domestic dispute located at [REDACTED]. Call notes stated O/C-Alivia Goncalves got into a physical fight with [REDACTED] and Goncalves was strangled by [REDACTED].

Deputies Flory, Davison and I arrived on scene at the above location. We contacted [REDACTED] at the door of the residence. [REDACTED] had what appeared to be [REDACTED]. I asked [REDACTED] to step outside of the residence so he and I could speak. I asked where Goncalves was and [REDACTED] stated she was inside the residence on the lower floor. Deputy Davison went to contact her while Deputy Flory and I spoke with [REDACTED] outside. I asked [REDACTED] if he needed medical attention and he stated no.

(First of two contacts with [REDACTED] [REDACTED] told me the following in summary:

At approximately between 2145 hours and 2150 hours he and [REDACTED] got into an argument that became physical. The argument was because [REDACTED] was still awake and not helping Goncalves put their [REDACTED] [REDACTED] to sleep. [REDACTED] went on to say he was upstairs with his father in law watching television when Goncalves began to argue with him about how [REDACTED] needed to go to bed. [REDACTED] stated he went downstairs to where their kids were sleeping and went to hold [REDACTED] who was sleeping on a bunkbed. [REDACTED] went on to say Goncalves became angry and began to yell at [REDACTED]. [REDACTED] added Goncalves began to scratch at him with both hands. [REDACTED] stated he put [REDACTED] down and put his right hand on the back of Goncalves's head to try and calm her down. I asked [REDACTED] how long they had been married and if this had happened before. [REDACTED] stated they have been married since 2019 and this had not happened before.

I asked [REDACTED] why he put his right hand behind Goncalves's head and he stated he was trying to swing her around and push her off. I asked [REDACTED] what happened after that and [REDACTED] stated he was able to separate from her and they both stopped fighting. I asked [REDACTED] if he put his hands around Goncalves's neck and he stated no.

I asked Deputy Flory to stand by with [REDACTED] outside while I contacted Goncalves downstairs. When I saw Goncalves I was able to see a [REDACTED]

I contacted Goncalves and she stated the following in summary:

Goncalves immediately stated that whatever happened was "probably" her fault and she was in the wrong. I asked Goncalves to explain what had happened tonight. Goncalves stated she did not remember because it was dark. I asked Goncalves what happened to her nose and her neck and she stated it was probably from [REDACTED] trying to get away from her. I informed Goncalves I wanted to hear her side of the story and she continued to state she did not remember, it was "probably" her fault and she did not want anyone to get into trouble.

Deputy Davison informed Goncalves that from the evidence we have and from what she had been telling us, she was going to go to jail tonight for a felony domestic battery. Goncalves immediately stated the truth was [REDACTED] attempted to strangle her approximately five to six times.

I asked Goncalves to explain what had happened. Goncalves stated she got upset with [REDACTED] because he was still awake and not helping put their two children to bed. Goncalves went on to say she continued to argue with [REDACTED] as they both walked downstairs and into the bedroom where the children were sleeping. Goncalves stated the children were sleeping in a bunk bed and both were sleeping on the lower bed. Goncalves went on to say [REDACTED] climbed onto the top of the bunk bed and laid down. Goncalves stated she was still upset with [REDACTED] so she climbed up to the top bunk bed to continue arguing with him.

Goncalves stated once she got on the top bunk bed with [REDACTED], he pinned her down on the bed and used wither his forearm or something else and pressed down on her neck. Goncalves added she was able to get away and then went back onto the top of the bunk bed. Goncalves stated she got off the bunk bed and back onto the bunk bed approximately five or six times. I asked Goncalves why she kept going back up and she stated she did not know. I asked Goncalves how did [REDACTED] get the [REDACTED] Goncalves stated the last two times [REDACTED] pinned her down she scratched him but she was unable to say where she scratched [REDACTED] on his face and body. Goncalves added [REDACTED] heard what had happened and separated the two of them.

During my contact with Goncalves she stated multiple times that she was scared for her life and stated her voice was fluctuating in tone. While Goncalves was speaking to me I did not hear or notice any fluctuation in the tone of her voice.

I went back outside to contact [REDACTED] again.

I informed [REDACTED] I spoke with Goncalves. I also informed [REDACTED] that what occurred tonight was a serious offense. I asked [REDACTED] to clarify what had happened tonight. [REDACTED] story did not change but he did add an event. [REDACTED] stated he did try to go to the top bed of the bunk bed via a small ladder but before he made it to the top Goncalves grabbed onto him. [REDACTED] went on to say Goncalves began to scratch at him repeatedly until they both got down to the ground and he was able to separate from her. I asked [REDACTED] how Goncalves got a [REDACTED] [REDACTED] stated it was from him trying to push her off of him.

Due to Goncalves changing her story after being informed of the consequences and the injuries to both her and [REDACTED] showing Goncalves was the primary aggressor I went back downstairs and informed Goncalves she was under arrest for felony domestic battery. As I was walking Goncalves up the stairs to exit the residence, [REDACTED] came out of a room. I asked [REDACTED] if she saw or heard anything and she stated she did not see anything but did hear screaming. I asked [REDACTED] if she was able to hear what the screams were saying and [REDACTED] stated no.

Just before I walked Goncalves out to my patrol vehicle, [REDACTED] said to Goncalves that she should not have called 911 because this was going to happen.

I walked Goncalves to my patrol vehicle, searched her, placed handcuffs on her and sat her down in my patrol vehicle.

I left a domestic violence pamphlet at the residence for [REDACTED] and filled out the IRAD form.

I photographed both [REDACTED] and Goncalves's [REDACTED] and uploaded the photographs to a CISO server for evidence.

I transported Goncalves to PSB and left her in the custody of the jail deputies.

Due to the facts and statements above I believe Goncalves was in violation of IC19-918 Felony Domestic Battery.

This incident was captured on my in-car dash camera as well as my body worn camera. For the complete details and circumstances of this case please refer to the videos. This report is a summary of the events to my best ability.
