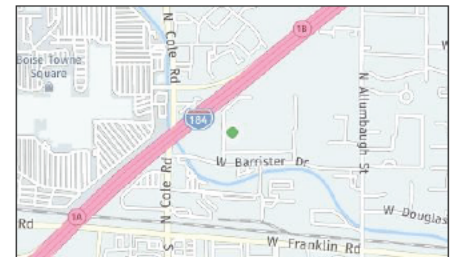

INITIAL RESPONSE/CONTACT:

On the above date and time, I was working as a Sgt. for the Boise Police Dept. in full uniform and working a foot beat in the downtown area. As I was working Officer Echols and I started watching a subject, later identified as Dominic Thomas, arguing with security at Dirty Little Roddys Bar located on 6th street. As Dominic was arguing with the staff I watched a male, later identified as John Showalter, shove Dominic over a knee-high railing. This caused Dominic to fall backward and land on the ground. At that time, John started to walk away. Dominic then stood up and walked toward John. I then saw both subjects engage in a physical altercation.

Officer Echols then tackled John onto the ground to stop the fight. I placed my hand on Dominic's chest and told him to stop. Dominic then grabbed my vest and pushed past me to get to John. I then yelled at Dominic that I was the Boise Police and pushed him toward the brick wall to stop his actions. Dominic was then taken into custody without incident.

I then handed Dominic off to Officer Westendorf and Officer Rush to be taken across the street. I did this because Office Echols was still taking John into custody on the ground in front of the bar.

When the scene was secured, I walked over to where Dominic was sitting. Officer Westendorf advised that they had found a marijuana vape pen on Dominic's person. Dominic was transported to the Ada County Jail by Officer Vassallo.
