On 9/21/2019, at approximately 2245 hours, Officer Tesdahl and I were on a plain clothes alcohol emphasis detail in the area of Taylor Ave. I saw a female walking near the 700 block of Taylor Ave with an unopened 19 oz White Claw (alcoholic seltzer beverage). Officer Tesdahl and I walked up to Mogen, displayed our badges and identified ourselves as Moscow Police Officers.

I asked Mogen how old she was. She told me she was 21 years old. When I asked Mogen for her ID she dropped the Ruby Grapefruit White Claw can on the ground and started to walk away from me. I placed Mogen in handcuffs and told her she was being detained for an alcohol offense investigation. Mogen admitted to only being 18 years old. I cited Mogen for the MIP (Citation # 61162) and released her on scene.

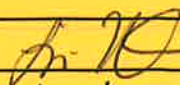
