Narrative:

On 03/08/2025 at approximately 0123 hours, Officer Westendorf and I were located across the street from the Amsterdam Lounge located 607 W Main St, Boise. I observed two males later identified as Mason Bangeman and Nikolas Meza start pushing each other and were yelling at each other. I began to approach the two suspects when they began to engage in a mutual fight by punching each other.

Officer Westendorf gained control of Nikolas and placed his handcuffs on him. Officer Westendorf escorted him to the patrol vehicle. See Officer Westendorf's supplement report for further.

Interaction with Mason Bangeman:

The following is a summary of my interaction with Mason.

I walked behind Mason and gained control of him. I placed my handcuffs on him, I checked them for tightness and double locked them. I walked Mason to the front of my patrol vehicle. I asked Mason if he had any drugs, weapons or anything illegal on him. Mason told me he did not. I searched Mason and removed his phone and wallet from his person.

Mason told me he fought Nikolas because "he was talking shit". Mason apologized about the situation.

I placed Mason in the back of my patrol vehicle and transported him to the Ada County Jail. Once we arrived in the jail and I removed him from the car, I asked Mason if he had anything illegal on him before he entered the jail. Mason told me he did not have anything illegal.

We entered the jail and Deputy E. Wilson took control of Mason. Deputy Wilson searched him and found a small baggy with white powder on his left breast jacket pocket. Deputy Wilson gave me the small baggy with white powder.

I provided the Miranda warning to Mason and he told me he understood. I asked Mason what was in the small baggy. Mason looked at me and did respond. I took Mason's silence as an invocation of his right to remain silent, so I stopped further questioning.

During my interaction with Mason, I observed that he was bleeding from the nose. I asked Mason if he wanted me to request paramedics, but he denied them.

Disposition:

Mason was transported to the Ada County Jail and booked for disturbing the peace, possession of control substance and introduction to a secure facility.

Nikolas was transported to the Ada County Jail and booked for disturbing the peace.

I tested the white powder, it tested presumptive positive for cocaine. I uploaded the photograph of the baggy and the test to AXON Evidence.

I booked the white powder into the Ada County Sheriff's property room. The weight of the baggy was 0.82 grams. I requested the substance be sent to Idaho state lab to be tested.

On the above date and time , I was operating as a training car with my trainee Officer Lozano. We were standing on the north side of Main street in front of City Hall. We observed two males arguing in front of the Amsterdam entrance. As we continued to watch them we saw one suspect wearing a white hat, later identified as Mason Bangeman shove the other suspect wearing a dark sweatshirt, later identified as Nikolas Meza. Nikolas and Mason began to throw punches at each other.

Officer Lozano and I crossed Main St and placed both subjects under arrest for disturbing the peace. When I grabbed ahold of Nikolas he began to pull away from me. I told him to stop and moved him to the parking lane where a white dodge charger was parked and pushed him down onto the hood so I could handcuff him with Sgt Jacobs help. Officer Lozano had Mason in handcuffs and we escorted both suspects to the east side of City Hall where our patrol vehicles were. I searched Nikolas and placed his wallet and phone into a property bag. I did not locate anything else on his person.

Officer Otazua responded to the scene to transport Nikolas to the Ada County Jail for us. Office Lozano placed Mason in the back of our patrol vehicle. Both subjects were transported to the Ada County Jail without incident.

Mason was advised by Officer Lozano to tell him if he had anything illegal on him. Mason denied having anything. While being booked the Jail deputy located a baggie of what I recognized to be cocaine based on my training and experience. Officer Lozano tested, booked and completed a prelog for the baggie. Mason was also charged with Possession of a Controlled Substance and Introduction into a jail facility.
