Reason for Hearing: Resident Kohberger is being referred to Administrative Segregation for the protection of staff and residents, as well as for his protection.

No DOR history

Resident:

- Understands the logic of his placement in Administrative Segregation
- Originally wanted the Protective Custody route, but due to his exposure in the media sees that Protective Custody is not an option right now
- Believes any harassment he has received from the other residents will die down once media coverage slows
- Is hopeful he can one day have recreation with others and live with others like him, "just like another high-profile resident on J2 does"
- Wants to work and be productive eventually
- Requested that he continue to have recreation alone and be escorted alone at this time
